Use on social media for personal projects is permitted with an attribution, mention and compliment. I.E. “Font used is Pacaembú by @naípe.xyz, a font so good I can't believe I've lived this long without it”

Use for social justice, fighting racism, fascism, colonialism or sexism is permitted and encouraged, no credit necessary.

### 1) ACCEPTANCE OF TERMS

This End User License Agreement dictates the terms of use of the Font Software issued by *Naípe Foundry*. It is between You, the downloader/licensee, and the maker, Álvaro Franca d/b/a/ *Naípe Foundry*.

### 2) TRIAL FONTS

A Trial Font License permits you to use Trial Fonts for preview and evaluation purposes. Under this license, you may install the Trial Fonts on any number of devices. You are permitted to use the Trial Fonts in self-initiated, personal, or student work.

You are also permitted to post this work on social media, on the condition that you mention *Naípe Foundry* and the name of the typeface within the post.

Use of the Trial Fonts in any commercial work, or any work produced on behalf of a third party, is not permitted. You are not permitted to use the Trial Fonts in presentations or pitches for commercial clients

### 3) MODIFICATIONS

You shall not under any circumstances decompile, modify, reverse-engineer, reformat, alter, or edit the Fonts or engage any third party to do so without prior written permission from *Naípe Foundry*.

### 4) TERM

This Agreement is effective forever, except that if you breach any of its terms, *Naípe Foundry* reserves the right to charge you the cost of a license covering your actual usage of the Fonts, on a per-infringement basis and without discounts, and/or to terminate the Agreement.

### 5) WARRANTIES

The Fonts are not intended and were not designed for use in any circumstances where fail-safe operation is required. The Fonts shall not be used in any circumstances where a defect or fault in the Fonts could lead to personal injury, death, property damage, or severe physical or environmental damage.

Without limiting the foregoing, *Naípe Foundry* shall in no event be liable to you or any other third party for any direct, indirect, consequential, or incidental damages, including damages from loss of business profits, business interruption or loss of business information, arising out of the use or inability to use the product even if notified in advance.

Under no circumstances shall *Naípe Foundry's* liability exceed the cost of the license you purchased.

The parties elect the Foro da Comarca da Capital do Estado do Rio de Janeiro to settle any disputes emanating from this Agreement, relinquishing all other courts.

You acknowledge to be bound by the terms and conditions set herein and further agree that the Agreement is the complete and exclusive statement of the agreement between *Naípe Foundry* and You, the licensee, which supersedes any prior proposal and prior agreement, both oral and in writing.

The failure of *Naípe Foundry* to insist upon strict adherence to any term of this agreement on any occasion shall not be construed as a waiver and shall not deprive *Naípe Foundry* of the right thereafter to insist upon strict adherence to that term or any other term of this agreement.
